## **Discipline – Institutional Suspension**

### 1. PURPOSE:

To allow the Institution to temporarily relieve a resident or fellow from clinical and educational duties so that the Institution may conduct an investigation of potential violations of institutional policies and/or standards of conduct.

### 2. <u>SCOPE:</u>

This policy applies to trainees (Trainees) in all ACGME, Council on Podiatric Medical Education (CPME), and Commission on Dental Accreditation (CODA) accredited post-graduate training programs sponsored by Carilion Medical Center (CMC).

#### 3. DEFINITIONS:

Institutional Suspension: an action that may be taken by the DIO to temporarily relieve a Trainee of duty when it is alleged that the Trainee has been involved in a significant violation of Institutional policies, engaged in a significant violation of professional or ethical behavioral expectations, or exhibited an inability to provide patient care without jeopardizing the health and safety of patients, employees, staff or visitors. The period of Institutional Suspension allows the Institution to conduct an investigation of the allegations against the Trainee and to determine and recommend an appropriate course of action. Institutional Suspension is not a disciplinary action in and of itself. It is not reportable as "disciplinary action." The Trainee will continue to receive full pay and benefits during a period of Institutional Suspension.

#### 4. PROCEDURE:

A Trainee may be suspended from clinical activities by their Program Director or the Designated Institutional Official (DIO). This action may be taken to temporarily relieve a Trainee of duty when it is alleged that the Trainee has been involved in a significant violation of Carilion Clinic policies, engaged in a significant violation of professional or ethical behavioral expectations, or exhibited an inability to provide

patient care without jeopardizing the health and safety of patients, employees, staff or visitors.

The Trainee will be notified by verbal and written notification of the suspension. This notification will include potential outcomes for the Trainee once the investigation is completed. The suspension of a Trainee's clinical activities must be reviewed within five (5) business days by the program director, their designee, or the DIO to determine whether the Trainee may return to clinical activities and/or whether further action is warranted including, but not limited to, continued investigation, remediation, fitness for duty evaluation, or dismissal. The trainee will continue to receive full pay and benefits during a period of suspension.
